7.15 APOLOGIES FOR ABSENCE

8.15 DECLARATIONS OF INTEREST AND DISPENSATIONS

- i. Cllr N Barclay declared a personal interest in the planning application for a proposed dwelling north of Elstow House, as the applicant is a friend.
- ii. Cllr C Green declared a personal interest in the planning application for a proposed dwelling north of Elstow House, as he and the applicant both serve on a local committee.
- iii. Cllr C Green declared a personal interest in the Cross Keys agenda items as a member of the Cross Keys Action Committee.
- iv. Cllr C Green National Grid Mid Wales Connection project (Dispensation granted 17th June 2013 Minute Ref 104/13)
- v. Cllr R Bright declared a disclosable pecuniary interest in the planning appeal for land at Sandyman, as the applicant.
- vi. Cllr S Quayle declared a disclosable pecuniary interest in the planning application for The Cottage, as the applicant.
- vii. Cllr S Bruce declared a personal interest in the agenda items relating to the Cross Keys as she is a neighbour and it was noted that Cllr B Cambidge will take the chair for these agenda items.

9.15 PUBLIC PARTICIPATION SESSION

A member of the public addressed the meeting about his planning application for a proposed dwelling to the north of Elstow House. Background was given on the outline application for a self-build sustainable house with low environmental impact which is intended for personal use. This is an outline application but more detail than is required has been provided to provide a vision. Details of the specifications of the house were provided. The location is on an un-adopted lane with three existing properties and is within safe walking distance of the centre of Kinnerley and local amenities which means it meets sustainability criteria.

A member of the public advised the meeting that there are Government proposals to change planning rules for community pubs. He advised that he would be on Radio Shropshire the following morning about how these proposed changes would affect Kinnerley. He reminded the Parish Council of the importance of the appeal to build on the beer garden and how it may be linked to the current planning application.

- iii. Cllr A Walpole (Shropshire Councillor) gave a report which included information about financial matters, including the work currently being undertaken on budget setting. There are still considerable savings to be made which will include further reductions in staff numbers. The decision on the payment of Council Tax Support Grant is still to be considered by full Council. In planning the SAMDev inspection has been completed and the report from the Planning Inspector is awaited. The implications of the new Care Act are still being considered. An update on National Grid would be given during the agenda item.

During this agenda item Standing Orders were suspended and resumed to allow the Councillors to ask, relevant members of the public, questions.

- ii. 14/05493/LBC Works to Listed Building to facilitate conversion of former public house to three dwellings and erection of one dwelling with associated detached garage - Proposed Residential Development Cross Keys Inn Kinnerley Oswestry Shropshire SY10 8DB
- iii. Planning appeal 14/02864/FUL Erection of 1 dwelling with detached garage (revised schemes) Cross Keys, Kinnerley, SY10 8DB Planning Inspectorate ref: APP/L3245/W/14/3001275

Both planning applications and the planning appeal were considered together. A draft response for the planning application, as agreed at the previous meeting, was tabled and discussed.

RESOLVED to strongly object to both planning applications and the planning appeal. It was agreed to delegate the planning application responses to the Clerk in liaison with ClIr C Green and ClIr N Barclay, based on the tabled draft response. It was agreed that the appeal response should also include a detailed heritage assessment and viability report so approval was given for liaison with relevant individuals. It was agreed to delegate the final appeal response to the Clerk in liaison with ClIr C Green and ClIr N Barclay. It was resolved to write to the Secretary of State via the local MP to request retrieval of this appeal, so that it can be considered as part of the whole planning submission, as this is an exceptional basis.

Cllr S Bruce requested that it be recorded that she had abstained from the above vote on the above resolution.

14.15 PLANNING APPLICATIONS

The following planning applications were considered

i. 14/05517/OUT - Outline application (landscaping reserved) for the erection of one detached dwelling; formation of vehicular access and installation of sewage treatment plant - Proposed Dwelling North Of Elstow House Kinnerley Shropshire

RESOLVED to object to this planning application as it is contrary to the Kinnerley Parish Neigbourhood Plan and outside the development boundary. As such it is in open countryside, where new development is strictly controlled under policy CS5 of Shropshire Council's Core Strategy and only limited types of development, such as accommodation for essential countryside workers and other affordable housing, is permitted. This site is not identified in SAMDev for housing. The proposal fails to satisfy the three dimensions to sustainable development in the NPPF: economic, social and environmental. Given that Shropshire Council has a five year housing land supply, the scheme is not necessary to meet the County's housing development requirements or the community's needs in terms of health, social and cultural well-being. It also fails to accord with and therefore undermines the strategy for the location of housing. The optimized into the countryside on the edge of the village and fails to protect or enhance the natural environment.

Cllr R Bright requested that it be minuted that he did not participate in this agenda item.

Cllr N Barclay requested that it be recorded that he had abstained from the vote on the above resolution.

Cllr S Quayle left the meeting and took no part in the next agenda item

ii. 14/05574/FUL - Erection of single storey side extension to form kitchen/utility and day room - The Cottage Kinnerley Oswestry SY10 8DF

RESOLVED that the Parish Council supports this planning application

CIIr S Quayle returned to the meeting.

iii. 14/05727/FUL - Erection of an outbuilding following demolition of existing outbuildings -Montbretia Turfmoor Edgerley Kinnerley SY10 8EW

RESOLVED that the Parish Council supports this planning application.

 iv. 14/05774/FUL - Application under Section 73a of the Town and Country Planning Act 1990 for the erection of 11No dwellings, landscaping and associated car parking (re-submission)
Proposed Residential Development to the Rear of Maesercroft Kinnerley Oswestry Shropshire SY10 8EQ

RESOLVED that the Parish Council objects to this planning application. This application is premature as, we understand that, not all the other two bedroomed houses have been sold. There are concerns about additional traffic and the density of this estate. The Parish Council asked during the pre-application discussion that the road be widened in front of the plots 10 (and 11) but the developer has decided not to do this. This is visually a key plot on this estate and the Parish Council does not support this change.

v. 15/00031/PMBPA - Application for prior approval under part 3, class MB of the town & country planning (general permitted development) (Amendment & consequential provisions) (England) order 2014 for the change of use from agricultural use to residential use of a barn - Barn South Of Kynaston House Kynaston Kinnerley Shropshire

RESOLVED to register a holding objection with the planning officer until further information on the existing barn is available.

vi. 14/05758/FUL - Conversion of traditional farm buildings into one dwelling with erection of triple garage with workshop and storage, installation of septic tank together with formation of new access - Treginford Farm Kynaston Kinnerley Shropshire SY10 8EF

RESOLVED that the Parish Council supports this planning application.

RESOLVED to approve the budget and a precept of £21,000

RESOLVED to pay the room hire fee of £20 on behalf of the Cross Keys Action Committee.

Cllr C Green requested that it be recorded that he had abstained from the vote on the above resolution.

19.15 NATIONAL GRID - MID WALES CONNECTION

Cllr C Green gave a verbal update which included information on the current formal pre-submission consultation response and a report from a public meeting held at Maesbrook was tabled and noted. A meeting of local Parish Councils with Cllr A Walpole and Ian Kilby, head of planning at Shropshire Council was due to take place the next day and it was noted that Cllr C Green, Cllr D Slaughter and the Clerk would attend this meeting.

20.15 HIGHWAYS – to be completed

The following was reported:

- i. Cllr A Lewis reported that bollards are missing on the bends in Maesbrook.
- ii. Cllr B Jones asked that the Parish Council writes to Highways about more work being done to improve the Royal Hill to Pentre road. It was agreed to request a multi-agency meeting to consider

improvements needed to Pentre and also the Quabbs. There are also three large potholes that need repairing.

- iii. Cllr R Bright reported that there is considerable mud on the road by Knockin Heath Business Park.
- iv. Cllr S Quayle reported complaints about residents parking on pavements around Lady Ida/Mountside. It was agreed to put a reminder in the Telescope.
