60.16 PUBLIC PARTICIPATION SESSION

A member of the public raised concerns about planning application – 16/01549/FUL – formation of an agricultural field access at Knockin Heath, and advised the Parish Council that some of the statements made in the application were incorrect, in his opinion. He advised that there is already access to the field via the other lane and there is no need for another access into the field. He

raised concerns about the slope in the field which will make it impossible to take a tractor and trailer through the gate into the field and that it would be dangerous for large vehicles. As his drive is opposite the gate it would need to be used if vehicles were struggling to pass each other.

61.16 CONNECTING SHROPSHIRE PROJECT

Chris Taylor, Shropshire Council's Connecting Shropshire Programme Manager gave a presentation on fibre broadband provision for Kinnerley Parish and answered questions from Councillors and members of the public.

Cllr Walpole advised that he supported the Conservation Area designation in principle, subject to feedback from consultees, including home owners within the proposed area. Following the March meeting it was reported that Corrie Davies, Shropshire Council, Community Enablement Officer had looked into funding options for the Cross Keys.

73.16 SHROPSHIRE COUNCIL ROAD SAFETY POLICY

The Shropshire Council Road Safety Policy was considered

RESOLVED to submit the following community led concerns.

- i. Maesbrook-Strong community concern about speeding traffic exceeding current 40mph speed limit. Note: ATC still outstanding
- ii. Kinnerley-Community concerns about speeding traffic through the village particularly pass the school. Lack of visibility on the church bend junction with Vicarage Lane.
- iii. Coly Anchor, Kinnerley (development behind the school) Concerns about speeding traffic on Coly Anchor (housing estate) which will be made worse when the estate is extended (currently being built). Local residents have requested speed calming measures (speed cushions). Petition from local residents submitted to Parish Council.
- iv. Whip Lane, Maesbrook-Speeding vehicles on Whip Lane, particularly HGVs, who use as a cut through from Llynclys to Knockin road (B4396). This is a single track road and needs "passing places only" signage at either end of Whip Lane, Osbaston. (Also requested by Knockin Parish Council)
- v. Maesbrook-Road safety for walkers at either end of the village due to lack of footpath to the Llwyn-y-Go turn/Chapel and between the Black Horse and Fields Lane.
- vi. Maesbrook-Request for additional horse signs at either end of village.
- vii. Maesbrook Request to extend 40mph speed limit at Knockin end of village to include Pen-y-Parc.
