The previous minister had visited the area, but following Cabinet changes a new minister had been appointed. At the recent Shropshire Council Full Council meeting the Financial Strategy for 2018/19 and 2019/20 had been considered and it had been resolved to increase Council Tax by 3.99% which includes 2% for Adult Social Care. The Schools new funding formula is out for consultation and information has been sent out to Clerks about the procedures for Elections.

Comment: Kinnerley Parish Council considered the revised plans and agreed to support this application in principle, but only subject to satisfactory resolution of the continued concerns about the access and parking as outlined in our previous comments.

iv. 16/04719/FUL - Erection of residential development of 18 no. dwellings; formation of vehicular access - Proposed Residential Development Opposite School Kinnerley

The meeting was advised that this application was to be considered by Shropshire Council's Planning Committee on 28th February 2017.

RESOLVED that CIIr C Green should attend the meeting and make representation to the committee. A draft representation was tabled and subject to removal of reference to the design of the houses, it was approved.

Cllr B Cambidge abstained from the vote for the above planning application.
